# ITEM #2. PUBLIC COMMENT

Supervisor Eppolito stated that at this point he will open the Public Comment period. It is a chance to address the Board on issues that are not on the agenda. He asks that you keep it to three minutes or so and that you address the entire Board, not individual Board members, and everybody speaks just once if you would. So, is anyone here to address the Board on anything that is not on the agenda.

April 8, 2010

- a) Carolyn Robinson addressed the Board. She wanted to ask the Board to lower the speed limit on Trevett Road to 45 mph. There are new homes in the area and the other end of the road is 45 mph. This would be from Genesee Road to Route 39. Discussion by the Board. He would bring this up under New Business. Mrs. Robinson thanked the Board.
- b) Mr. Donhauser asked the Board about the Crown Castle replacement tower. He had heard a rumor about this and there were stakes put up. Supervisor Eppolito thought that it was repairing, not replacing. Mr. Donhauser heard that they wanted to replace it. Town Clerk Bolt stated that the paperwork she had seen said build and put the equipment on the new one. Supervisor Eppolito thought it was not to change in size. The CEO had felt that it was a repair, not replacement. Tn. Attn. Barone stated that even if it was a replacement, it is exempt according to our law. No building fee is required. Mr. Donhauser asked what if it was in a different location. Tn. Attn. Barone and Supervisor Eppolito stated that it would change things. Mr. Donhauser stated that there is a stake and test hole 30-40 feet away from the old tower. Tn. Attn. Barone stated that he will have to check the code then. Mr. Donhauser thought that if a new tower was built, wouldn't that have to abide by the new code? Tn. Attn. Barone agreed but the telecommunications law does not have anything on building permits. He would have to go to the building permit chapter of the code to review that. Councilman Krezmien asked how we would know what it is if not checked out by the CEO. Supervisor Eppolito stated that the CEO will have to check it out. Discussion. Tn. Attn. Barone thought that another application should be made by a special use permit or an amendment to the existing one. Nothing has been filed to date. Supervisor Eppolito will review this with the CEO.

- c) Award Mowing Bid Supervisor Eppolito explained to the Board that only one bid had been received. As it is under the \$1,000 limit, he felt that it could be done with Request for Proposal. Councilman Krezmien moved to throw the bid out for lack of suitable bidders and authorize the supervisor to do a Request for Proposal for the Spaulding Cemetery, seconded by Councilman Salzler. Councilwoman King, Councilmen Krezmien& Salzler, Supervisor Eppolito, voting aye; Councilman Snyder, excused. Carried.
- i) Natural Resources Conservation Service Project Agreement Supervisor Eppolito explained that he had received the actual contract and replaced the tentative one already sent to the Board. The project cost would be \$181,690, but the town will absorb the engineering costs and doing any trucking of gravel. The easement from Mrs. Dunn expires the end of June so this needs to be approved and the work started. Motion by Councilman Krezmien, seconded by Councilman Salzler, to accept the project agreement for the Kissing Bridge site and authorizing the Supervisor to sign said agreement and all related contracts. Councilwoman King, Councilmen Krezmien& Salzler, Supervisor Eppolito, voting aye; Councilman Snyder, excused. Carried.
- e) Dream Katchers Use of Town Hall Town Clerk Bolt had received a letter requesting use of the town hall for a karaoke night for the challenged individuals in the area. They were also requesting to waive the fee. It would be May 22<sup>nd</sup> from 6-8 pm. Town Clerk Bolt brought this before the Board as they are using the hall more and more and the Board had only approved the first two uses. There have been no problems. They would also like to use the hall for a Halloween party. Discussion. Motion by Councilwoman King, seconded by Councilman Salzler, to waive the fee this time, but in the future the fee may be reinstated. Councilwoman King, Councilmen Krezmien& Salzler, Supervisor Eppolito, voting aye; Councilman Snyder, excused. Carried.

## g) Authorize Town Clerk to Advertise for Craneridge Sewer Bids -

Supervisor Eppolito explained the problems with the sewer system in Craneridge. He would like to open them May 7<sup>th</sup>. The scope is more than FEMA had allowed. He and Supt. Dains have been in negotiations to allow for more funding. Motion by Councilman Krezmien, seconded by Councilman Salzler, to direct the town clerk to advertise for the Craneridge Sewer Bids. Councilwoman King, Councilmen Krezmien& Salzler, Supervisor Eppolito, voting aye; Councilman Snyder, excused. Carried.

h) Cattaraugus Street Water Resolution – Supervisor Eppolito explained that a Resolution was now needed to continue towards the Cattaraugus Street Water District. Councilman Krezmien moved the adoption of Resolution 14, seconded by Councilwoman King:

April 8, 2010

WHEREAS, The Town Board of the Town of Concord plans construction of the Cattaraugus Street Water District, and

WHEREAS, The Town does not have sufficient funds on hand to pay for all the construction of the Cattaraugus Street Water District, and

WHEREAS, This project may be eligible for federal government funding through the USDA/Rural Development to construct the Cattaraugus Street Water District, and

WHEREAS, It is in the interest of the public to obtain low interest loans and/or grants for the construction of the Cattaraugus Street Water District

NOW, THEREFORE BE IT

RESOLVED, That the Supervisor and Deputy Supervisor of the Town of Concord is authorized to cause an application to be prepared to obtain funding from USDA/Rural Development, and

BE IT FURTHER RESOLVED, That the Supervisor and Deputy Supervisor be authorized to execute all application documents and forms required to determine funding eligibility and to obtain specific funding for the project from USDA/Rural Development.

i) Trevett Road Speed Limit Resolution – Supervisor Eppolito asked for a resolution to request a speed limit reduction on Trevett Road from Genesee Road to Route 39. Councilwoman King moved the adoption of Resolution 15, seconded by Councilman Salzler:

WHEREAS, Trevett Road is a County Road, and

WHEREAS, There have been numerous accidents with the many curves and dips in the road, and

WHEREAS, Many new homes have been built in the area, and

WHEREAS, The speed is already 45 mph from Genesee Road to the Concord Town Line and this would continue south from Genesee Road to Route 39, and

WHEREAS, The Town Board is concerned with the safety of its residents, as well as those using Trevett Road

NOW, THEREFORE BE IT RESOLVED, That the Town Board of the Town of Concord does hereby request the County of Erie to reduce the speed limit to 45 mph on Trevett Road from Genesee Road to Route 39.

WHEREAS, A Public Hearing had been held on Thursday, March 11<sup>th</sup>, 2010, with no one speaking in opposition, and

WHEREAS, The Concord Town Board wishes to make the Town Park Rules and Regulations a policy, and not a local law

NOW, THEREFORE BE IT

RESOLVED, That the Concord Town Board hereby adopts

#### Local Law No. 1 of 2010

Rescinding Local Law No. 1 of 1993 entitled "Town of Concord Town Park Rules & Regulations" and Local Law No. 3 of 1995 "Codes of Town of Concord" Chapter 101 – Parks and Recreation Areas, Sections 101-2, E; 101-3 and 101-7.

### **EFFECTIVE DATE**

This Local Law shall take effect upon filing in the Office of the New York State Secretary of State or as otherwise provided by law.
